## EXCLUSION OF LIABILITY, RELEASE & INDEMNITY

In exchange for being able to attend or participate in the Motorsport Activities, I agree:

- to release VMRC and the Entities to the extent that any or all of them are providing Recreational Services from all liability for:
  - my death; any physical or mental injury (including the aggravation, acceleration or recurrence of such an injury);
  - o the contraction, aggravation or acceleration of a disease;
- the coming into existence, the aggravation, acceleration or recurrence of any other condition, circumstance, occurrence, activity, form of behaviour, course of conduct or state of affairs:
  - o that is or may be harmful or disadvantageous to me or the community; or
  - o that may result in harm or disadvantage to me or the community, howsoever arising from my participation in or attendance at the Motorsport Activities;
- to indemnify and hold harmless and keep indemnified VMRC and the Entities to the maximum extent permitted by law in respect of any Claim by any
- person; and attend at or participate in the Motorsport Activities at my own risk.

I acknowledge and agree that it is a fundamental condition of issue of this licence and its continuing validity that I:

- 1. have advised VMRC in writing of any act, omission, fact or circumstance which may affect my ability to be and remain a fit and proper person to hold this licence and exercise the duties and privileges that relate to it;
- 2. have advised VMRC in writing if I have been found guilty of or charged with a serious indictable criminal offence(s).

I acknowledge and agree that VMRC may, in its absolute discretion (subject to this clause) refuse to issue, suspend or withdraw this pass at any time should VMRC reasonably form the view that I may not be, or am not, a fit and proper person to be granted or hold this pass and/or exercise any of the duties and/ or privileges that arise from, or relate, to it.









## TERM S:
